New Business

Legislative updates – HB66 - Prohibiting mask, vaccine and testing discrimination regardless of vaccination status failed. HB80 – Medical treatment opportunity act-Medicaid reform also failed.

Wello scanners, purchased with grant money are located at Clinic entrance, ER entrance, and employee entrance. They scan temperatures, print out badges, send notifications and keep logs.

Public session reconvened at 6:24 p.m. Discussion was held regarding the State Survey and possible ramifications. It will be 4 years in June since NCH has been surveyed. She will be entering into an agreement with DNV.
